Judging will begin at 6:00 p.m.; contestants must be in line and ready to be judged. Spook and Pet Parade will step off promptly at 6:15 p.m.
4. All entries must be registered with liability waivers on file with Main Street Guymon. (located on application)
5. No motor powered vehicles are allowed.
6. No throwing of any objects from the parade contestant.
7. Entries must remain in position assigned, unless approved by a parade official.
8. An adult responsible for following all parade rules shall accompany youth under 10 years of age.
9. All Pets are required to have a collar and leash. All pets should be current on their shots.
10. Main Street Guymon Promotion Committee reserves the right to refuse any entries not conforming to family oriented quality and high standards of Main Street Guymon. Failure to comply with rules may result in removal from parade and will effect future invitations to participate. All Promotion Committee Decisions are final.
